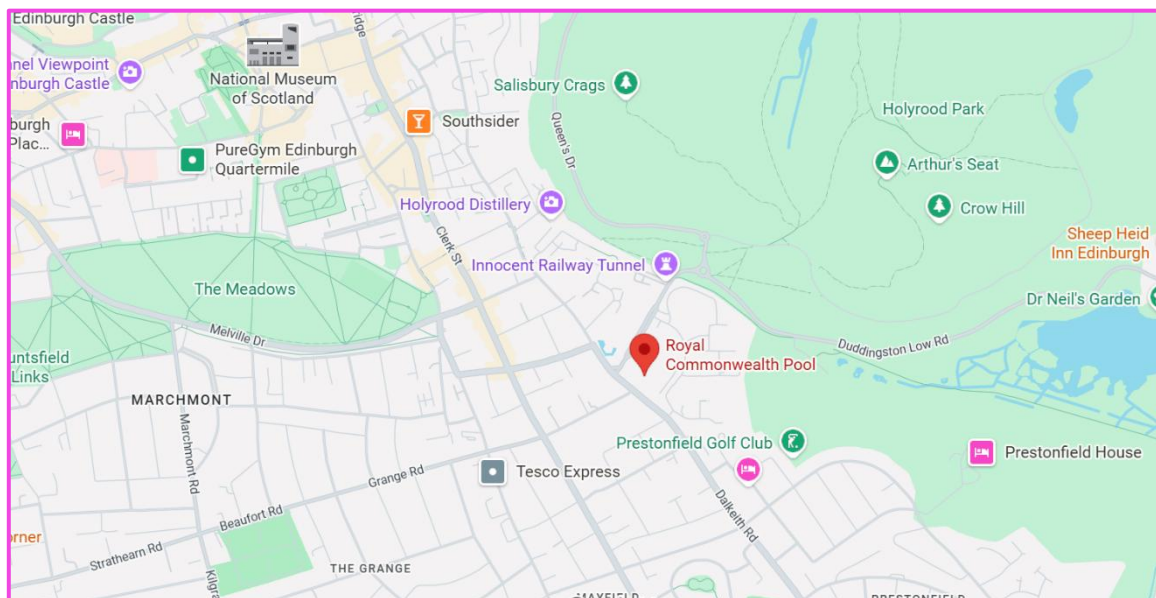

Disclosure and Barring Service (DBS) checks are required for Swim England members in regulated roles such as, Coaches, Team Staff and Chaperones. Further information for Swim England Members can be found [here](#).

If a DBS application was carried out through another organisation the certificate can be reused if registered with the [DBS Update Service](#). If you hold a disclosure that has been registered with the DBS Update Service, and you have not yet given the Swim England written consent to check the status, please submit your original disclosure certificate along with a completed consent form to dbs@swimming.org. Please also email dbs@swimming.org for a DBS Update Service Consent form.

Scottish Swimming/Swim Wales

For queries regarding PVG for Scottish Swimming members, please email wellbeingprotection@scottishswimming.com. For queries regarding DBS for Swim Wales members, please email welfare@swimwales.org.

PLEASE NOTE: Scottish Swimming, Swim Wales and International Poolside Passes must be created and sent manually therefore, there may be a delay in receiving your accreditation. They will be sent out prior to the event if you have the appropriate Safeguarding checks and qualifications on file.

DIVE SHEETS

Divers/Coaches are requested to submit dive sheets electronically, both for their own convenience and to minimize the chance of errors loading the data into the Recording program. Coaches may make bulk submission of dive sheets on behalf of their divers by using the program DiveSheets with which they will already be familiar. Alternatively, individual divers may submit their own dive sheets on-line. Please agree with your coach which method you should use. To submit your dive sheets on-line there are two options:

Electronic dive sheets must be submitted where possible. Electronic submissions must be made by 09:00 on Wednesday 8th April 2026. You will be asked to sign hard copies of these sheets at the venue, available from the Recorders.

If neither you nor your Coach are able to use the above electronic methods, you can submit a hard copy of your lists of dives to the Recorders at Royal Commonwealth Pool, Edinburgh.

If manual dive sheets need to be submitted, submissions must be by 17:00 on Wednesday 8th April 2026.

For late entries, please do not submit a dive sheet until the late entry has been submitted and processed.

2. MINIMUM PERFORMANCE STANDARDS

Aquatics GB Next Gen Diving Championships event conditions will adhere to World Aquatics Age Group Conditions with the exception of the following Group C events with specific clauses (C1-4):

GROUP C CLAUSES:

- (C1) Group C Events – are 13 years and under in the year of competition.
- (C2) Girls Group C – In all events 3 optional dives from 3 groups (prelim and finals).
- (C3) Group C 3m synchronised competitions (boys and girls) 3 dives of an assigned degree of difficulty and 2 optional dives.
- (C4) C Platform* Divers aged 11 years and under are allowed to compete on 7.5m, however it is the responsibility of the coach and diver to ensure the divers physical maturity and strength permit competing from a height of 7.5m.

4. FORMAT FOR AQUATICS GB NEXT GEN DIVING CHAMPIONSHIPS 2026:

- Age Group A, B and C divers will perform their full list of dives in the preliminary. The top eight (8) British divers will proceed to the final. A maximum of four (4) guest divers, but no more than two (2) per team/country, whose scores are equal to or better than the eighth placed British diver will also proceed to the final. If there are less than 8 British divers then a maximum of 4 guest divers, but no more than two per team/country, will progress to the final.
- In the final the divers will perform their optional dives, competing in the reverse order of their preliminary rankings, and the final result will be determined by adding their score from the final to that of the required dives total from the preliminary.
- No dive may be repeated in a list of dives. All dives in the preliminary and final, including that of the carried required dives must be of a different dive (dive number).
- Age Group categories and limits refer to the age of the diver on 31st December in the year of competition
- Minimum age for competitors is 9 years on 31 December in the year of competition
- Synchronised events will be straight finals.

5. COMPETITION FORMAT/REGULATIONS *(See also, General Conditions)*

- *All dives of the same number shall be regarded as the same dive.*
- *Only dives in the World Aquatics diving tables or pursuant with the World Aquatics formula may be executed.*
- *The diver and the diver's representative are responsible for the accuracy of the statement in their list and the statement of dives shall be signed by the diver and the diver's representative.*
- *Medals shall be awarded to the first three placed divers in each competition and where different, to the first three placed British divers (see General Conditions for definitions of British).*
- *Please consider the following clauses carefully when selecting events for your divers.*

6. ELIGIBILITY

To dive Synchro at the Aquatics GB Next Gen Diving Championships, both members of the pair must be diving at least 1 individual event at that Meet.

If a diver is not demonstrating the minimum standard of performance, the coach to the diver may be engaged by a member of Aquatics GB Diving Leadership Team and the event referee to discuss the most suitable performance level for the diver in the future.

7. GENERAL COMPETITION CONDITIONS FOR SWIM ENGLAND, SCOTTISH SWIMMING AND AQUATICS GB COMPETITIONS

- Once a diver has competed in the Aquatics GB Next Gen Diving Championships, Aquatics GB Winter Cup, Aquatics GB Diving Championships or Scottish National & Open Championships in any event (including synchro) they are not eligible to compete at National Skills finals.
- A diver who has competed at Aquatics GB Next Gen Diving Championships is not eligible to compete at the Swim England National Age Group Championships or Scottish National Age Groups, unless moving up an age category and with written approval from the Diving Leadership group (SE) or Scottish National Diving committee.

Failure to comply with these conditions will result in disqualification.

8. DEFINITIONS

Competing/competed. Divers are considered to be competing or to have competed at a certain level if they entered the contest – even if they did not dive due to injury or illness.

For example, if a diver was entered for the Aquatics GB Diving Championships, but did not dive due to injury they cannot compete at the Swim England Diving or Scottish National Age Group Championships.

9. INTERNATIONAL ENTRIES

International Federation Team and International Club Team entries are welcome at the Aquatics GB Next Gen Diving Championships 2026.

- Two divers per international team may enter each competition. Teams may request to enter more than 2 divers in an event but only 2 divers per nation can go through to the finals.
- GB Teams have unlimited number of entries, but they should have achieved the recommend qualification standard in the preceding 12 months.
- The final will be made up of the top 8 British Divers
- Up to 4 international divers may proceed to the final, but **only** if they rank in the top 8 of the Aquatics GB Junior Elite preliminary event.
- A minimum of 8 British Divers will progress to the final.
- If more than 4 non-British Divers place in the top 8 in the preliminary round, only the top 4 will progress to the final.

10. ATHLETE COMPETITION SWIMSUITS

British Divers are required to either wear club costumes or costumes without national team branding. This applies to both GB National Team and International Team branded swimsuits (example no international team costumes are permitted). International divers may wear either their own national team kit or unbranded suits, but not GB National team swimsuits.

11. ANTI-DOPING

By entering this event you/your child (if athlete is under 18), consent to report to Doping Control if requested at any time during this event. You further agree to be bound by the [British Swimming Anti-Doping Rules 2021](#).

DIVE GYM PRIZES

The top British athlete in each age category (A, B and C) on each board (1m, 3m and Platform) with the highest scoring set of required dives (1st 5 dives on springboard & 1st 4 dives on platform) from the preliminary round, will receive a Dive Gym gift. This prize is for individual events only.

DOPING CONTROL

If an athlete is subject to doping control, they should ensure they provide detail of all medications (prescribed or over the counter and including dosage) and supplements taken within the last 7 days in advance of the test and (where the sample collected is a blood sample) blood transfusions within the previous three (3) months, on the Doping Control Form.

If the medication you are taking is prohibited in or out of competition you may require a TUE. Please read the details below.

Therapeutic Use Exemption (TUE)

BRITISH ATHLETES ONLY (International athletes please see below)

If an athlete **IS WITHIN** the National TUE Pool, they are required to obtain a TUE before using a prohibited medication or method. You can check if you are within the National TUE Pool via <https://www.ukad.org.uk/national-tue-pool> and selecting 'aquatics'.

If an athlete is **NOT** within the National TUE Pool but using a prohibited medication or method **and** is subject to doping control they are required to apply for a retroactive TUE. Athletes are encouraged to notify UKAD they wish to apply for a retroactive TUE as soon as possible following doping control (tue@ukad.org.uk)

INTERNATIONAL ATHLETES ONLY (British athletes, please see above)

If you are an international athlete requiring a TUE, please contact either your National Federation, your National Anti-Doping Organisation or World Aquatics.

Strict Liability means an athlete is wholly responsible for any banned substance found in their system, no matter how it got there.

As a safety precaution and in line with best practice, we recommend that if you or your athlete is required to attend doping control, another individual remains on site to accompany you or the athlete to their destination afterwards, to ensure they are not alone.

SECURITY / HEALTH AND SAFETY

Security staff will be on site at the venue, checking all accredited persons at key access points to the venue and the pool and carrying out ticket checks for spectators.

The health, safety, and wellbeing of all staff, volunteers, athletes, and spectators is our top priority. It is essential that every member of the workforce understands their role in maintaining a safe environment and knows how to act in the event of an incident.

Incident Reporting Procedure

All incidents, accidents, or near misses — whether involving workforce members, athletes, or the public — must be reported immediately. This includes:

- Injuries (minor or serious)
- Illnesses
- Sexual Misconduct/Harassment
- Unsafe conditions or hazards
- Damage to equipment or infrastructure
- Security concerns or suspicious behaviour

To report an incident:

1. Ensure safety first – If there is immediate danger, alert your Team Leader, venue staff, event organisers or on-site medics.
2. Notify the Event Organisers – provide clear details of the incident.
3. If necessary, complete an Incident Report Form.
4. Follow instructions – Remain available to assist if needed, and do not leave the area unless instructed.
5. If you are ever unsure of how to respond to a situation, speak to the Event Organisers immediately.

Aquatics GB will work with Edinburgh Leisure to ensure that the venue is safe for all participants and for the competition to take place to World Aquatics Standards adhering to all UK health and safety guidance. A full risk assessment of the event will be completed and checked daily.

Unwanted conduct of a sexual nature which has the purpose or effect of violating an individual's dignity, or creating an intimidating, hostile, degrading, humiliating or offensive environment.

4 Types of sexual harassment

VERBAL/WITTEN

- Remarks of a sexual nature about a person's clothing, personal behaviour or body
- Sexually explicit statements, questions, jokes or anecdotes
- Requesting sexual favours or dates
- Spreading rumours about a person's personal life
- Coercion of sexual activity by threat of punishment
- Excessive and unwelcome flirting

PHYSICAL

- Impeding or blocking a person's physical movement
- Inappropriate and unwanted touching of a person and/or their clothing
- Other inappropriate touching including kissing, hugging, patting, stroking or rubbing
- Playing music with offensive or degrading language
- Purposefully brushing up against another person

NON-VERBAL

- Looking a person's body up and down
- Making derogatory gestures or facial expressions of a sexual nature
- Frequently following or standing too close to a person on purpose
- Whistling or staring in a sexually suggestive or offensive manner

VISUAL

- Displaying sexually suggestive objects, pictures, cartoons, posters, calendars or computer screens
- Showing other people sexually suggestive text messages or emails
- Sharing sexually inappropriate images or videos such as pornography

FILMING AND PHOTOGRAPHY POLICY

Aquatics GB is committed to ensuring that all children who participate in Aquatics GB activities can take part in an enjoyable, safe environment and be safeguarded from harm. If you have any child safeguarding concerns at the event, please contact an Event Officer immediately to disclose your concerns.
