INFRINGEMENTS THAT CARRY A WARNING FOR FIRST OCCURRENCE	
START	
3.15.3	Swimmer not present in the assembly area at the required time prior to the start
4.1.1	Swimmer did not start from assigned position, when starting from a fixed platform
4.8	Unfair advantage gained at the start
4.9	Swimmer's escort craft interfered with another competitor at the start
RACE	
3.8.4	Swimmer failed to maintain clearance from another swimmer when so instructed
5.2	Swimmer failed to cease pacing or slip-streaming with their escort craft when instructed to move clear
5.4	Escort craft failed to move clear when warned they are pacing or slip-streaming a swimmer
5.8.1	Escort craft not displaying their swimmer's competitor number
5.12	Pacing of a swimmer by another person entering the water
5.13	Use of a whistle by the swimmer's representative
5.15	Object, rope or wire, hanging off feeding pole (other than swimmer's permitted identity flag)
5.16	Feeding pole exceeds 5 metres in length when extended
INFRINGEMENTS RESULTING IN IMMEDIATE DISQUALIFICATION	
RACE	
3.9.1	Swimmer failed to execute the alterations in course as indicated in the competition information documents
5.3.2	'Unsporting' action by a swimmer, swimmer's escort craft or swimmers approved representative
5.4	Escort craft deliberately obstructing or placing themselves directly in front of another swimmer
5.6	Walking or jumping off the bottom during a race
5.7	Swimmer receiving support from a fixed or floating object (other than the water bottom) Swimmer intentionally touched escort craft or crew therein
1.2.1	Team relay handover between swimmers not visible above the water, following swimmer not holding starting position prior to touch, touch not made between elbow and hand
FINISH	
8.1.2.1	Swimmer failed to correctly enter and remain within the marked boundary of the course at the finish (where used)
6.2	Swimmer finished race without at least one transponder (where issued)
6.3	Swimmer failed to touch the vertical wall at the finish (where used)
OTHER INFRINGEMENTS	
SWIMMER AND EQUIPMENT	
7.1	More than one swimsuit in one or two pieces worn Swimsuit worn not compliant with WA Competition Regulations (15.1) and the FRSA
7.1	Swimsuit covers the neck, extends past the shoulder, or extends to below the ankle
7.3	Wetsuit fails to completely cover torso, back, shoulders, and knees (When criteria requires use) Wetsuit extends beyond the neck, wrists or ankles.
3.15.2	Swimmer failed to trim fingernails and/or toenails when so instructed Swimmer failed to remove jewellery, including watches when so instructed
5.10	Swimmer wearing a device which may be an aid to their speed, endurance or buoyancy. More than two (2) caps being worn
5.11	Swimmer using excessive greases or other such substances

Swimmer shall be given an opportunity to take corrective action, change swimwear, remove jewellery and watches, and trim nails prior to the start. Failure to comply may result in swimmer being given a Warning, a Disqualification, or not being permitted to swim.
